Suitable for following majors at KAZGUU: International Law, Law, Law Enforcement (check the possibility to choose courses of Host University with your advisor before applying)

NB! Please note that these undergraduate students will be enrolled as graduate (Master's) students in SNU law school during their study.

Period of study: Fall semester – September 1st – January 31st

Spring semester – March 1st – June 30th (dates may vary, student has to arrive a week prior to semester for orientation if required)

Online application deadline: September 20th, March 20th (Selection at home University 1 month prior to nomination)

<u>Deadlines for document selection at Home University:</u> Selection during September and February, deadlines are announced in social media and Platonus

Eligibility: GPA 3,0 and above, IELTS overall band score 6.0; TOEFL IBT 88 or above, or KEPT Level B2

Availability: for 1 students per semester

Required documents for Home University selection: Application form, 2 signed recommendation letters from teaching staff in free form, Individual study plan (address to your adviser), official transcript in English, confirmation from parents, citizens application. Language proficiency test results, if student does not have he/she takes KEPT at Home University. After student's candidacy is approved he/she has to provide Learning agreement, Health certificate 082 and invitation letter from accepting University.

Application to SNU:

1) After being nominated student have to fill SNU online application before deadlines. Provide certificate of enrolment, official University Transcript, Letter of Recomendation according to SNU Template, passport information page copy, a statement of Purpose (free essay in English).

After provision of these documents to the Office of International Affairs of SNU designated department will screen documents during late October or late April. Academic mobility is possible in case if the student receives Notification of acceptance from SNU in early November or May.

Study apportunities: tuition fee is waived for Host University, all expences have to be covered by student also, tuition fee should be paid to Home University.

Approximate expenditures:

Accomodation	680 KRW per month
Food	40-70 USD per month
Transport	50 USD per month
Personal expences	80 USD per month

^{*}Expences may vary depending on personal preferences. Student spends usually 500 euro per month.
